BUILDING MAINTENANCE AND WINTER PREPARATION With the cold weather soon approaching, it is always helpful to ensure that all necessary and preparatory steps have been taken to protect parish buildings and property from the elements. In the past, the archdiocese experienced over \$12 million in property losses, a significant amount of which was the result of weather-related damage. Now is the time to work closely with your maintenance manager before winter sets in to get your property and buildings in shape to avoid an emergency. There is one more maintenance presentation to be held on Tuesday, November 28 at Sacred Heart in Monroe. Refer to the memo Winter Building Maintenance in the Updates section of the combined mailing.

NO ONE TO ANSWERED THE PARISH TELEPHONE? With modern technology today, an urgent contact with a priest should be easily facilitated, especially whenever there is no secretary at the parish office. Different churches use various systems, such as commercial answering services, a dedicated "duty priest" mobile phone, call forwarding, etc. What should be avoided is any parish system where no priest can be contacted for several hours for a crucial matter.

UPCOMING NATIONAL COLLECTIONS The collection for the *Retired Religious* of the archdiocese will be on December 10; and the combined collection for the *Catholic Communications Campaign* and the *Catholic University of America* will be on January 7, 2024. *War Relief in Israel* is at the discretion of the pastor.

CONSTRUCTING, RENOVATING, AND RESTORING PLACES OF WORSHIP When planning the construction, renovation, or restoration of a church or chapel, be sure to consult the archdiocesan *Financial Policies and Procedures Manual* (located in the Library section) for guidance regarding the proposal and approval processes for these projects. It is summarized below:

- The vicar general must approve the concept.
- Both the project management firm (PMF), Zubatkin and the archdiocesan office of liturgy must be contacted for all projects that involve any change, modification, or addition to a church or chapel, regardless of the cost involved.
- At the inception of the project, any change, especially to the sanctuary, regardless of size or cost, the pastor/administrator should notify the PMF and the office of liturgy of his intent to modify a worship space during the concept stage of the project. The PMF will assist the pastor/administrator in submitting a letter of request to the vicar general.
- In the letter, the pastor/administrator should describe the proposed change(s) and the purpose of the change(s). After receiving approval from the vicar general, the pastor/administrator should meet with the PMF and the office of liturgy to develop the RFA and review the construction and liturgical aspects of the project.
- Schematic designs should then be completed and presented to the office of liturgy for review and approval via an RFA. The office of liturgy is assisted by the archdiocesan liturgical art and architecture commission in this process. This submitted portfolio should include a proposed floor plan of the existing and planned space, a drawing of all relevant liturgical appointments, an elevated drawing of the sanctuary and reredos, and a description of the liturgical change(s) to the worship space and the purpose of the change(s).
- Upon receipt of the schematic designs, the office of liturgy will typically arrange a site visit and complete a report with its observations and recommendations.
- Once approval has been given, any subsequent modifications to the schematic designs should be resubmitted to the office of liturgy and the PMF using the same procedure. Questions may be directed to the archdiocesan director of property management or the office of liturgy.

ADVENT DAY OF RECOLLECTION FOR PRIESTS will be held on Wednesday, December 6 from 1:00 to 4:00 PM at Dunwoodie and it will be led by His Eminence, Cardinal Dolan. The day will begin with exposition, reflections, confession, and benediction. Lunch will be available for those who request it beforehand. More information will be forthcoming. The Lenten day of recollection at Dunwoodie will be Thursday, February 28, 2024 from 1:00 to 4:00 PM.

BISHOPS FOR CONFIRMATION As we prepare for the 2024 confirmation season, know that each auxiliary bishop maintains his own schedule and wishes to be responsible for his regional area. A master schedule is maintained at the office of the vicar general. Bishops are the ordinary ministers of confirmation for previously baptized and catechized Catholics, whether children or adults. WHEN MAY A PRIEST CONFIRM? The 1983 code of canon law states (c.882): "The ordinary minister of confirmation is a bishop; a presbyter provided with this faculty in virtue of universal law, or the special grant of a competent authority also confers this sacrament validly." It is often asked, "Under what conditions may a priest confirm?" See Library section [Confirmation~When May A Priest Confirm].

SCALLYWAGS AND SCOUNDRELS Father Martin Onyebuchi, a priest of the Diocese of Okigwe, Nigeria, is not permitted to function in any ministerial capacity in any church or facility of the Archdiocese of New York or to reside in any rectory or church-owned or sponsored building and is not to have any role in any parish or Catholic-sponsored activity within the confines of the Archdiocese of New York. At one time about fifteen years ago, Father was at Our Lady of Sorrows in White Plains. His immigration status is unknown.

PERPETUAL ADORATION CHAPEL Cardinal Dolan recently dedicated a perpetual adoration chapel in Manhattan, the first of its kind on the island. The chapel, located at St. Joseph in the West Village, is meant to be a 24-hour oasis of prayer for all Catholics in the archdiocese. People may register at *perpetualadoration.nyc* and then come by the parish office at St. Joseph (371 Sixth Avenue) to pick up a keycard that will grant them access to the chapel whenever they want, day or night. The keycard system was developed after much thought over how to make the chapel both accessible and safe for adorers. The deadline for updates is expected to be three weeks after the portal opens. Once the portal is closed and locked, no more changes can be made. RECONCILIATION MONDAY DATES Observed since 2011, Advent Reconciliation Monday will be held on December 18, 2023 from 2:00 to 4:00 PM and 6:00 to 8:00 PM in the archdiocese and the Diocese of Brooklyn. Lenten Reconciliation Monday will be observed on March 25, 2024 from 2:00 to 4:00 and 6:00 to 9:00 PM in the archdiocese and the Dioceses of Brooklyn and Rockville Centre, in every parish from the east end of Long Island to the Catskills. FOUR ESSENTIAL ESTATE PLANNING DOCUMENTS You do not have to be an expert to create a successful estate plan. The department of development can help priests to use their estate plans to further the work of the Church.

- Last Will and Testament and/or Trust: controls how your assets, such as money and property are distributed after your lifetime. Without a will, the state of New York decides what happens to your assets. Trusts allow you to make special arrangements for the management of your assets for yourself and others, such as sheltering assets, benefiting heirs or your favorite non-profits.
- Durable Power of Attorney for Finances: names a person who will have the legal right to handle financial matters on your behalf if you ae unable to do so.
- Durable Power of Attorney for Health Care: also known as a health care proxy, this document addresses all medical treatment. It names one or more individuals you trust to make medical decisions on your behalf if you are incapacitated.

CHRISTMAS 2023 This year, the faithful will have two distinct obligations to attend Mass: one for the IV Sunday of Advent and the other for the Nativity of the Lord (Monday). In other words, the obligation is to attend Mass twice, once for the Advent Sunday and then, for Christmas. Also, each priest may celebrate three Masses in a 24-hour day (midnight to midnight) on December 24 and December 25. January 1, 2024 will not be held as a day of obligation because it occurs on a Monday. You may wish to take this into account when planning your Mass schedule and your holy day collection.

FLOWERS FOR HOLY WEEK Palm Sunday is March 24, just four months away, so now is the time to be thinking about your needs and order from ICS as soon as you can. Whenever we band with ICS, the savings are great. Collectively, the parishes of the archdiocese are a huge customer. Almost more important than the price is the guaranteed timely delivery. When the ICS order reaches one million palm strips, (a very reasonable number, actually) it qualifies for priority shipping from the producer in Alamo, Texas. This means that all the palm comes in a single dedicated refrigerated shipment. Fresh palms are delivered to our parishes. Don't delay. See the ICS info in this mailing and order before Advent commands your attention.

ADMINISTRATIVE FEES FOR MARRIAGE ANNULMENTS Back in 2015 in the Year of Mercy, Pope Francis asked that annulments be granted free of charge. After that year, administrative fees were reinstated. Beginning November 1, the fees will change again. For a formal case, the application fee will be \$100 and the administrative fee (the proceeding itself) will be \$900. For a lack of canonical form (c. 1108), the fee will be \$100. Always remember that no one is ever turned away from the tribunal because of an inability to pay.
